Staggered Glass Table Lamp Assembly Instructions

Important Safety Instructions:

- This portable luminaire has a polarized plug (one blade is wider than the other) as a safety feature to reduce the risk of electric shock. This plug will fit in a polarized outlet only one way. If the plug does not fit fully in the outlet, reverse the plug. If it still does not fit, contact a qualified electrician. Never use with an extension cord unless plug can be fully inserted. Do not alter the plug. Do not attempt to defeat this safety feature.
- These instructions are provided for your safety. It is very important that they are read carefully and completely before beginning the assembly and installation of this lighting fixture.
- This fixture has been rated for up to one (1) 40-watt maximum TYPE G standard incandescent light bulb (not included) or one (1) 9-watt compact fluorescent light bulb (not included) or one (1) 12-watt maximum SBLED light bulb (5-watt SBLED light bulb included). To avoid the risk of fire, do not exceed the recommended lamp wattage.
- This lamp is meant for indoor use. DRY LOCATIONS ONLY.
- Save these instructions.

WARNING:

- To reduce the risk of fire, electrical shock or personal injury, always turn off and unplug the light fixture and allow it to cool prior to replacing the light bulb.
- Do not touch bulb when fixture is turned on. Do not look directly at lit bulb.
- · Keep flammable materials away from lit bulb.


Pre-assembly:

- Remove all parts and hardware from box along with any plastic protective packaging.
- Do not discard any contents until after assembly is complete to avoid accidentally discarding small parts or


hardware.

Parts Included:


- (A) Socket Ring (1)
- (B) Spacer (1)
- (C) Glass Shade (1)
- (D) Socket (1)
- (E) Stem (1)




To Assemble:




Unscrew the Socket Ring (A) and Spacer (B) from the Socket
 (D) by rotating the Socket Ring (B) in a counter-clockwise direction.



 Attach the Glass Shade (C) onto the Socket (D). Place the Spacer (B) onto the Socket (D). Secure Glass Shade (C) and Spacer (B) by rotating the Socket Ring (A) in a clockwise direction until tight.



3. Insert the specified light bulb into the Socket (E). DO NOT EXCEED THE SPECIFIED WATTAGE.



4. Plug the power cord into the proper electrical outlet and test fixture.

Note: There is one USB Port on the fixture base, which can be used for charging USB devices (USB charging cable is not included). The output maximum is 5V/2A. Do not overcharge.

Care instructions:

- Wipe clean with a soft, dry cloth or static duster.
- Always avoid the use of harsh chemicals or abrasive cleaners as they may cause damage to the fixture's finish.
