#### **WARNING:**


- Do not touch LED's when fixture is turned on. Do not look directly at lit LED.

- Do not discard any contents until after assembly is complete to avoid accidentally discarding small parts or hardware.



- (C) Lower Tube (1)
- (D) Upper Tube (1)
- (E) Light Rods Assembly (1)





### To Assemble:




 Attach the Upper Tube (D) onto the bottom threaded end of Light Rods Assembly (E) by rotating the Upper Tube (D) in a clockwise direction until tight.

2. Attach the Lower Tube (C) onto the Upper Tube (D) by rotating the Lower Tube (C) in a clockwise direction until tight.



3. Gently pull and remove any slack power cord out from the Base (A). Attach the Lower Tube (C) onto Thread Nipple (B) of Base (A) by rotating the Lower Tube (C) in a clockwise direction until tight.



Gently rotate the light rods to your desired angles. Do
not hand on the white plastic rod part for rotating.
 Remove the protective film on the white plastic rod once
installation done.
